Navigating the form to make the Complaint process more user friendly for Stakeholders and will start the process of removing South Dakota to an "Adequate Status" with PHMSA.

- 5. Proposed Rules Draft review and schedule outline
  - a. The Board will review the schedule, milestones timeline and dates associated.

- ii. Once authorization to proceed, the scheduled hearing will be officially scheduled at board meeting. Notices in newspaper and letters will be provided to multiple individuals and agencies. This must be completed 20 days prior to the public hearing. Interim Rules committee will not meet until Legislative Session is complete. The drafts are only considered drafts currently as input from the public and LRC will be considered for changes. At this time, the schedule is a rough outline.
- 6. Clarification from the Board on Complaint Management
  - a. Currently with complaints, it is required that the violation of the State Law must be listed. All documentation should be completed before it reaches the Enforcement Panel. This is a modification that will be reviewed with the Complaint process to provide more clarity.
