Under the authority granted by SDCL-49-7A-22, the Enforcement Panel of the South Dakota One Call Notification Board met on August 29, 2024 to determine whether there is probable cause to believe a One Call violation occurred in Complaint Docket OC24-018. The Enforcement Panel's findings are enclosed. You may request a hearing according to SDCL-49-7A-27, if you disagree with the Enforcement Panel findings. If you do request a hearing you must be represented by legal counsel at the time you present your case to the One Call Board.

**If you choose to request a hearing you must return the signed and dated form prior to the close of business on October 14, 2024.**
